#### INDEPENDENT AUDITOR'S REPORT

For the Executive Director of Internews-Kosova Pristina - Kosovo

#### **Opinion**

We have audited the financial statements provided by the Internews Kosova NGO (based in Prishtina, Kosovo), including financial position statements as of December 31, 2019 and 2020, comprehensive statements of income and cash flow statements for the previous year, and notes relating to these financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements fairly represent, in all material respects, the financial position of Internews Kosova as of December 31, 2019, as well as its financial performance and cash flow for the previous year, which are in accordance with the accounting policies and procedures disclosed in Note 2 to the accompanying financial statements.

#### The Basis for Opinion

We conducted our audit in accordance with the International Standards on Auditing (ISAs), our responsibilities deriving from which are further described in the Auditor's Responsibilities section in the Audit of the Financial Statements chapter of our report.

We are independent of the Company, in accordance with the ethical requirements relevant to our auditing of financial statements in Kosovo and have fulfilled all other responsibilities set out by these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

#### Governance and Governance Responsibilities in regard to Financial Statements

Management is responsible for the preparation and fair presentation of financial statements in accordance with the accounting basis disclosed in Note 2 accompanying the financial statements, as well as with any internal controls management determines is necessary to enable preparation of a statement that is free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the organisation's ability to continue as a going concern, disclosing, as applicable, matters related to the going concern and using the going concern basis of accounting, unless management either intends to liquidate the organisation or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the organisation's financial reporting process.

#### 1. GENERAL INFORMATION

Internews Kosova was registered in Prishtina as a non-governmental organization, with registration number no.51100831-6 on June 25, 2001, on the basis of the United Nations Interim Administration Mission in Kosovo (UNMIK) Regulations. After the constitution of the Kosovo Government was adopted, Internews Kosova received an NGO Registration Certificate with the same registration number from the Registration and Liaison Department of NGOs at the the Ministry of Public Services.

The fiscal number of Internews Kosova is 600171433, while the number denoting its public beneficiary status is 6001174-5.

The organization's headquarters are at the following address: Mensa e Studentëve, Kati I, Prishtinë, Kosovë.

Internews Kosova's activities are focused on training programs, television production, research reporting, analysis, debates, monitoring and advocacy, as well as the development of media organizations. Since 2005, Internews Kosova has co-produced the shows: Life in Kosovo, Life in the Municipality, Justice in Kosovo and KALLXOPernime.

In 2011, Internews Kosova established the online anti-corruption platform KALLXO.com, which publishes stories on corruption, tax evasion, public spending and other public interest issues. This platform enables citizens to report directly on their problems while the KALLXO.com research team confirms the reports received.

Internews Kosova also works closely with BIRN Kosovo, with the two organisations collectively monitoring the justice and public procurement system in Kosovo.

Throughout 2020, Internews Kosovo has continuously worked to increase citizens' access to accurate information by researching, producing articles and broadcasting debates and reports on issues including the COVID-19 pandemic, good governance, education, the economy, social issues, the empowerment of women and their engagement in society, the prevention of violent extremism, electoral and post-election reporting, public spending, higher education, human rights and access to justice.

In 2020, Internews Kosova published 19,288 articles through its online anti-corruption platform at KALLXO.com. Of this total, 782 were in-depth analyses, surveys or interviews, while 129 were fact-checking stories as part of its 'Krypometer' section. Meanwhile, a total of 21 articles were written by trained young people which were published on the KALLXO Youth platform.

In cooperation with BIRN Kosovo, its main partner, Internews Kosova also produced 78 television programs in 2020, including episodes of its Life in Kosovo and Justice in Kosovo series, which feature investigations, reports and debates. About 920 guests appeared in the programs in 2020, while more than 150 interviews with the public were conducted.

Internews Kosova's statistics show that during this reporting period, the respective pages for Life in Kosovo, Justice in Kosovo and KALLXO.com, collected a total of 24,335,795 views on Youtube and 78,068,384 views on Facebook.

For the year ended 31 December 2020 (amounts in Euro)

The organisation's work during 2020 particularly focused on reporting to the public about the COVID-19 pandemic. Since the outbreak of the first case in Kosovo in March, the KALLXO.com team has reported consistently and accurately on the crisis, including reports from affected areas.

Our team produced more than 2,100 articles, including analyses, news stories, and live reporting. We also broadcast more than fifty (50) live interviews with mayors, doctors, health experts and representatives from Kosovo's National Institute of Public Health, and produced 100 reports and 30 infographics and illustrations on COVID-19 and the effects of the spread of coronavirus.

KALLXO.com also identified and reported over 50 cases of fake news, which had the potential to create panic and uncertainty among the public and published updated information and expert advice on the latest situation regarding the coronavirus epidemic.

In addition, KALLXO.com provided assistance to the Ministry of Education, Science and Technology in developing an online distance learning platform, which was implemented for students who could not attend school due to the risk of infection.

The KALLXO.com team voluntarily filmed a series of:

- More than 2,000 e-learning video lessons in the Albanian language for pupils in grades 1 to 9;
- More than 1,000 e-learning videos in Bosnian and Turkish for students from grades 1 to 9 attending schools operating in these languages in Kosovo.

Videos in Bosnian and Turkish were broadcast on RTK2, while videos in Albanian were broadcast on RTK 1.

KALLXO was also part of the country's preparation to help avoid the crisis by analysing the preparation of Kosovo's institutions. Throughout the year, KALLXO.com reported on irregularities found during field research, including publication of an article on the lack of protective equipment for police and customs officials to help protect against coronavirus.

KALLXO.com also started an inspection / surveillance of toilets in Kosovo's health institutions and at the University of Prishtina, to check if they possess basic sanitary supplies like antibacterial soap and toilet paper.

Hospitals and family medicine centers were monitored in Prishtina, Gracanica, South and North Mitrovica, Gjakova, Prizren, Peja, Ferizaj and Gjilan, where soap and toilet paper were missing. Reporting on the lack of basic sanitary products in health institutions in Kosovo helped raise the alarm about a wider shortage of sanitary supplies in the health system.

KALLXO.com also received reports during the coronavirus crisis that the University Clinical Center of Kosovo does not have a contract for the supply of sanitary equipment, and investigated the case, publishing the findings.

Despite the health risks in continuing to report from the field during the pandemic, as well as the usual threats involved in reporting on powerful people in Kosovo, KALLXO.com and Internews Kosovo continued to hold those in power accountable and inform citizens objectively and without prejudice.

For the year ended 31 December 2020 (amounts in Euro)

About 50 direct interviews were broadcast with mayors and municipal officials to manage the situation from the field, while KALLXO.com also consistently reported on the lack of basic sanitary supplies when interviewing the directors of health departments in various municipalities in Kosovo.

Furthermore, Internews Kosova in cooperation with BIRN Kosovo aired the series "Heroes of the Pandemic" series, in which nine inspiring people who did extraordinary deeds for their communities were interviewed.

The legal office of KALLXO.com also analysed and researched reports submitted by citizens regarding violations of employment law and price hikes in shops. Within a week, the legal office was in communication with the Tax Administration of Kosovo and actions were taken against businesses that raised and manipulated prices during the COVID-19 pandemic.

Meanwhile, although legally employed citizens benefited from government assistance as a result of the COVID-19 pandemic, thousands of workers within the informal sector were left without financial assistance. Having a credible reputation with the citizens of Kosovo, people began to express their concerns, complaints and reports to KALLXO.com that they had not benefited from government assistance and that businesses had manipulated government funds intended for employees.

On October 5, 2020, Internews Kosova, in cooperation with BIRN Kosovo, began broadcasting a series of mid-term municipal television debates with mayors from across Kosovo as part of its Life in the Municipality series.

As part of the project, both organizations engaged their researchers to investigate municipal issues, placing local government in the spotlight at a time when mayors have only one year left until the end of their terms. The investigations also measured the fulfillment of the promises made by the mayors during the "Town Hall" debates that were produced by both organizations before the 2017 elections.

Internews Kosova and BIRN Kosovo broadcast 29 debates and 9 interviews as part of Life in the Municipality series in 2020, while a number of concrete actions were taken by the mayors following issues being raised during the debates.

Meanwhile, our team of court monitors, legal office and legal advisors monitored a total of 510 court hearings, filing 868 legal complaints at public institutions in Kosovo, of which 518 were requests for access to official documents. Internews Kosova's Legal Office also submitted 30 legal complaints to the Chief State Prosecutor Aleksander Lumezi as a result of irregularities encountered during our research and monitoring.

The Internews Kosova team participated in over 30 public appearances, conferences and debates to present the views of Internews Kosova and our research findings and field monitoring.

Contributing to daily investigative reporting, Internews Kosovo played a major role in combating organized crime and corruption in Kosovo through its professional team of staff, which was awarded a number of times in 2020.

For the year ended 31 December 2020 (amounts in Euro)

In October 2020, Internews Kosova journalist Behar Mustafa was awarded the second best story in the field of environmental reporting by the COHU NGO¹, for a story published in May 2020 entitled: Environmental Degradation funded by the State. The story revealed that some infrastructure projects funded by the state budget of Kosovo were implemented using illegally sourced materials that damaged the environment.²

On December 21, 2020, the editor-in-chief of KALLXO.com, Kreshnik Gashi, and journalist Aferdita Fejzullahu were awarded the third prize for their four-month investigation into how company owned by family members of the Deputy Minister of Infrastructure was involved in the construction of a road between Prishtina and Gjilan.

Even during the challenging year of 2020, Internews Kosova has continued to maintain constructive cooperation with public institutions including municipalities, the Ministry of Education and the Ministry of Local Governance, Prosecutions and Basic Courts across Kosovo's municipalities, the Kosovo Judicial Council and the Kosovo Prosecutorial Council, local media, and local organizations from all ethnic and cultural communities in Kosovo.

# 1. THE BASIS OF PREPARATION AND SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES

## 1.1. THE BASIS OF PREPARATION

The accompanying statement was prepared for reporting purposes to the Registration and Liaison Department and donors on Internews Kosova activities, in accordance with the objectives of the donor project, specified in detail in their implementation.

#### 1.2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies in preparing these financial statements is presented below:

#### 2.2.1. Accounting Convention

The financial report has been prepared by Internews Kosova, which saves the data in the Quick Books accounting software. The statement was prepared on an accrual basis. On this basis, income is recognized when spent and not when received by the donor and the costs are recognized when they occur and not when they are paid.

#### 2.2.2. Reporting Currency

Funds are accepted in euros, while expenditures are stable in euros (Kosovo's currency). The financial report is expressed in euros, showing the currency used by the Project in its operations. Transactions in currencies other than the euro are translated into euros at the relevant exchange rate ruling at the transaction date.

#### 2.2.3. Taxes

In accordance with the Contract Framework, projects are exempt from income tax. Taxes are granted in accordance with Kosovo's fiscal regulations and are currently calculated at a certain level of taxable income. Projects are responsible for personnel and social taxes and income tax according to Kosovo's regulations.

#### 2.2.4. Cash and Equivalents

Cash and cash equivalents include cash and bank deposits with high liquidity with an initial maturity of three months or less.

#### 2.2.5. Fixed Assets

Fixed assets are stated at costs, less accumulated depreciation. All equipment and other fixed assets are capitalized as fixed assets rather than expensed. For donor reporting purposes, they are reported as project costs based on budgets previously approved by Donors.

Depreciation is provided on a straight-line basis at the following annual rates:

#### 2.2.6. Receivables from Donors and Other Receivables

Receivables are stated at their net realizable value.

#### 2.2.7. Payables

Payables represent amounts due in relation to expenses recognized on accrual basis. Payables are stated at cost. As at 31 December 2020, outstanding payables related to services, tax, salaries, pension contributions and employment taxes.

#### 2.2.8. Balance of Funds

Fund balances are split between capital funds, operating funds, and restricted funds.

#### 2.2.9. Capital Funds

Capital funds represent the fixed assets of the organization. All movements in fixed assets (purchases, disposals, depreciation, revaluation, etc.) are accounted for through this fund.

#### Operating Funds

Operating funds show the resources available to the organization for its operations and include cash and other current assets.

#### Designated or Restricted Funds

Designated funds, also called "Restricted funds" are resources that have been earmarked for specific purposes and may not be used for the general operation of the organization without specific approval of the donor (or entity that imposed the restriction).

#### 2,2,10. Income

The funds earned are mainly derived from various donors. Donations are recognized as income when spent not when received.
